

System Overview

系統概述







- Requires the App to work with smart devices with Android 6 and above, or iOS 12 and above.
- There is no guarantee that the App will work well if the Operating System is below Android 6 or iOS 12.
- The Network Adaptor is designed specifically as a terminal for "KDK Ceiling Fan" App.
- The Wi-Fi network coverage must reach the ceiling fan installation location.
- This product may have latency in operation for 1 to 3 seconds due to the command need to send through the server.
- •1 ceiling fan can be registered by 4 user accounts.
- 1 user account can register and control 8 ceiling fan simultaneously.



Increase Fan Speed, maximum fan speed is 10.

3 '-' SPEED Button

Decrease Fan Speed, minimum fan speed is 1.

4 REVERSE Button

Change the direction of fan rotation (clockwise, anticlockwise).

⑤ 🦃 Wi-Fi Button

Press to activate or off the Ceiling Fan wireless network. "ON" - Short beeping sound. "OFF" - Long beeping sound.

6 NIGHT LIGHT Button

Press to select Night Light setting.

7 WARM COLOR Button

Press to select Light color - Warm.

8 WHITE COLOR Button

Press to select Light color - White.

9 '+' LIGHT Button

Increase light brightness gradually.

10 '-' LIGHT Button

Decrease light brightness gradually.

11 LIGHT OFF/ON Button

Turn off or turn on the Light. "ON" - Short beeping sound. "OFF" - Long beeping sound.


How to connect product to home network

如何將產品連接到家用網路

- ① After login, press "Connect product to network" to connect product.
- 2 Switch ON the ceiling fan from the wall switch.
- ③ If the fan is rotating after the wall switch is on, turn OFF the ceiling fan by pressing the OFF/ON button on remote control.
- Before connecting smart devices to product, please ensure your smart devices have been connected to your Wi-Fi router.
- (5) Press "Next".

Product registration in the App

- Products need to be registered before using "KDK Ceiling Fan" App.
- 1 Select one product to register by pressing "Registration".
- ② Press "Yes" if the buzzer is beeping. Otherwise, press "No" to follow the App to set ceiling fan to enter Wi-Fi setting mode.
- ③ Press the Remote Control ☐ button. The ceiling fan should change beeping sound to indicate that ceiling fan is connecting to the App. Then, press "Yes". Otherwise, press "No".





Use the "KDK Ceiling Fan" App

- 1 Press button to open the Main Menu.
- 2 Main Menu will display.
 - Connected product To check the product status.
 - · Group To check grouping status.
 - Help App assistance including FAQ, instruction manual.
- (3) Connected product
 - (a) Under Connected Product tab, to connect new product, press "Connect new product to network".
 - (b) Product registered and product not registered are shown. Press on any registered product to view the details such as "Name", "Model Number", "Serial number".
 - (c) Product and Lighting preset* can be renamed. Group selection can be changed also.
 - (d) Registered product could be removed from the App by pressing "Delete product" button.
 - If the product is registered by one or more user accounts, schedule setting will remain. If there is no other registered account, schedule setting will be deleted. This will not reset the network setting.

• To reset network and ceiling fan schedule settings please refer page 26.

SLEEP MODE function

- The operation pattern of SLEEP MODE: Fan reduces two speeds after every two hours (minimum speed 1), until the Ceiling Fan is turned OFF.

■ Note:

- SLEEP MODE can only use with OFF TIMER enabled.
- •To enable SLEEP MODE fan must be at least speed 2, and OFF timer must be at least 2 hours.
- SLEEP MODE function is deactivated, if TIMER SETTING is changed.
